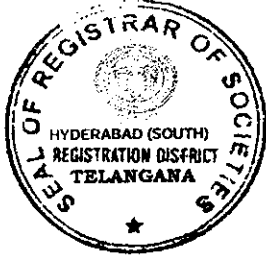

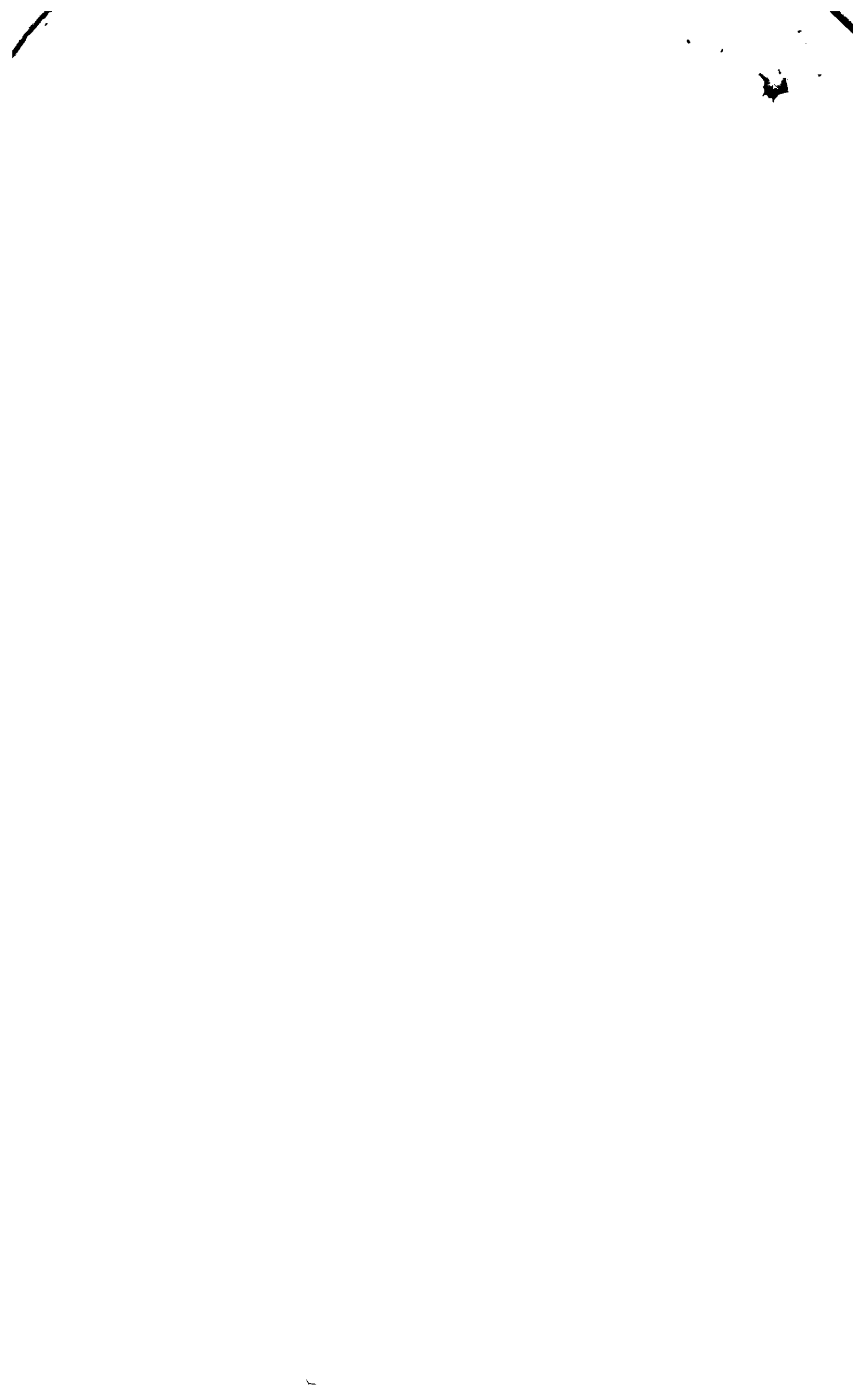
**SPECIAL RESOLUTION DT.05.05.2014 OF THE BOARD OF GOVERNORS

It is resolved

1. To divide the existing APTWREI Society into 2 Societies i.e., Andhra Pradesh Tribal Welfare Residential Educational Institutions Society for Residuary Andhra Pradesh State and Telangana Tribal Welfare Residential Educational Institutions Society for Telangana State.
2. Assets and Liabilities of Society shall be divided among the 2 new Societies as per the area of location and operation of institutions. The area of operation of Residuary Andhra Pradesh State is (13) districts of Seemandhra region and for Telangana State is (10) districts in the existing Telangana Region.
3. The Secretary, APTWREI Society is authorized to prepare Bye-laws for both the Societies and to take necessary steps for the division of Society into new Societies (AP Residuary State and Telangana State) on the above with the approval of Secretary to Govt., TWD/Vice-Chairman, APTWREI Society.

## Document – I

### MEMORANDUM OF ASSOCIATION

#### 1. NAME OF THE SOCIETY

The name of the Society is "The Telangana Tribal Welfare and Residential Educational Institutions Society (For Telangana)" (TTWREIS) hereinafter referred to as the "Society".


#### 2. LOCATION OF OFFICE

The Registered Office of the Society shall be situated at Hyderabad.

#### 3. AIMS & OBJECTS

The objects and purpose for which the Society is established are:

- a) to establish, maintain, control and manage Tribal Welfare, Residential Schools, Junior Colleges, Industrial Training Institutions and Polytechnic Colleges (Gurukulam Vidyalayamulu) for the talented and meritorious children belonging to Scheduled Tribes residing within the State of ~~TELANGANA~~ and to do all acts things necessary for or conducive to promotion of such schools and colleges.
- b) to affiliate and to accord recognition to similar Tribal Welfare Residential Schools, Institutes and Colleges established and run by any Society or private persons in the State.
- c) to prepare, introduce, supervise and modify from time to time the curricula, syllabi and other programmes and conduct of examination in regard to the education of pupils in the Tribal Welfare Residential Schools, Institutes and Colleges established by or affiliated to or recognized by the Society.
- d) to organize and conduct study courses, conferences, lectures, seminars, workshops, study tours and the like for the benefit of the staff and students of the Tribal Welfare Residential Schools, Institutes and Colleges.
- e) to create teaching, administrative, technical, ministerial and other posts under the Society and in the schools Institutes and Colleges.
- f) to constitute such committees, or other bodies as may be deemed fit and to prescribe by rules of the Society its powers, functions, tenure and other matters.
- g) to acquire, hold and dispose of property in any manner whatsoever for the purposes and in pursuance of the advancement of objects of the Society.
- h) to maintain a fund to which shall be credited:-
  - i) all moneys provided by the Central and State Governments.
  - j) all fees and other charges received by the Society.
  - k) all moneys received by the Society by way of grants, gifts, donations, benefactions, bequests or other wise and
  - l) all moneys received by the Society in any other manner or from any other source.
- m) to subscribe to or to become a member of or to cooperate with any other organization, institution or association having objects wholly or in part similar to those of the Society.
- n) to fix and collect such fees and other charges as may be laid down by the rules, bye-laws or regulations of the Society.





- o) to deposit all moneys credited into the fund in such banks or to invest in such manner as the Society may decide:
  - p) to borrow or raise moneys with or without securities or on the security of a mortgage, charge, hypothecation or pledge over all or any of the immovable or movable properties belonging to the Society or in any other manner:
  - q) to make or endorse on behalf of the Society and to accept or draw in favour of the Society any drafts, cheques and notes or other negotiable instruments on the discount of charges therefore and for this purpose to execute and sign, such deeds and documents, advance such moneys as may be considered expedient or necessary for the purposes of the Society;
  - r) to do all such acts or things as may be considered necessary, incidental or conducive to the attainment of all or any of the objects of the Society.
4. The Government of Telangana may, from time to time, appoint one or more persons to review the work and progress of the Society and to hold inquiries into the affairs of the Society and either SUO MOTO or on report made, give directions to the Society in regard to any matter in such manner as they may think fit for the furtherance of the objects of the Society and for ensuring its proper and efficient functioning and the Society shall be bound to comply with any such direction.




**DOCUMENT - II**  
**RULES AND REGULATIONS**

**1. NAME OF THE SOCIETY:**

The Telangana Tribal Welfare Residential Educational Institutions Society  
(for the State of Telangana).

**2. LOCATION OF THE OFFICER:**

The Registered Office of the Society shall be located at DSS Bhavan,  
Masab Tank, Hyderabad.

**3. DEFINITIONS:**

In these rules, unless the context otherwise requires:


- a. "Board" means the Board of Governors constituted under Article-5 of the Memorandum of Association
- b. "School" & "Colleges" means a Residential School, Junior College and Degree College (Gurukulam Vidyalayam) established by the Society or any other Residential School, Junior College or Degree College, affiliated or recognized by the society . "Secretary" means the person appointed as the Secretary to the Telangana Tribal Welfare Residential Educational Institutions Society.
- c. "Society" means the Telangana Tribal Welfare Residential Educational Institutions Society"

**4. MEMBERSHIP:**

The society shall have as its members all the persons representing the Board and such other persons as the Government of Telangana may at any time admit by nomination to be members of the society.

**5. GENERAL BODY:**

- i. All the members on the Board are members of the General Body.
- ii. Quorum for General Body shall be 1/3 of its members
- iii. There shall be an annual general body meeting of the society to be held at such time, date and place as may be determined by the Chairman in the month of April.





- iv. The Chairman may, at any time, convene meeting of the board or a special meeting of the society whenever he thinks necessary.

**6. POWERS AND FUNCTIONS OF THE BOARD:**

The board shall perform the following functions:

- a) To prepare and execute detailed plans and programs for the furtherance of the objects of the society.
- b) To administer the funds and to manage the properties of the society.
- c) To sanction and appoint such officers and other employees as may be required for the efficient management of the affairs of society and to regularize their recruitment and conditions of service.
- d) To enter into agreements for and on behalf of the society
- e) To appoint committees, study groups or working groups for disposal of any business of the society or for expert advice in any matter pertaining to the society.
- f) To make bye-laws for the regulation and conduct of business and management of the affairs of the society and for the furtherance of its object, including the allowances payable to the members and to annul, amend, vary or modify from time to time, the bye-laws so made. However, the existing Bye-laws & Recruitment Rules which are in force as on 01-06-2014 of the APTWREI SOCIETY will be adopted for the time being until they are adopted / modified / amended by the Board of Governors of the two new Societies.
- g) To make regulations for determining the conditions of service of the Secretary, other officers and employees of the society.
- h) To affiliate to the society any institution having object similar to those of the society or to recognize any other institutions.
- i) To perform such other functions as are necessary and expedient for furtherance of the object of the society and for carrying out its purposes.
- j) To perform functions entrusted to it by Government of Telangana.

**7. DURATION OF MEMBERSHIP:**

The term of the members of the society or board other than the Ex-Officio Members there of shall be for a period of three years from the date of their nomination.





8. **TERMINATION:**

The term of the nominated member of the Society or Board may be terminated by the authority, who is competent to nominate, at any time and the person who is nominated in his place shall hold office as member for a full term of three years from the date of his nomination.

9. **DISQUALIFICATION:**

A nominated member of the society or the board shall cease to be such member if:

- a) he becomes of unsound mind, or is adjudged by a competent court as insolvent or is convicted for a criminal offence involving moral turpitude; or
- b) he fails to attend three consecutive meetings of the board without obtaining leave of absence from the Chairman

10. **RESIGNATION:**

Any member of the society or board may resign from the membership of the society through a communication in writing addressed to the Society and it shall take effect when it has been accepted by the Chairman on behalf of the society.

11. **FILLING OF VACANCIES:**

- a) Any vacancy caused in the membership of the society by reason of death, resignation or otherwise shall be filled by nomination or appointment by the authorities entitled to make such nomination or appointment, as the case may be under these rules.
- b) No act of the society or board or any office of the society shall be deemed to be invalid by reason only of the existence of any vacancy or any defect in the organization of the society or in the formation of the board or in the appointment or nomination of a member or officer on the ground that such member or officer was disqualified for this office.

12. **AUTHORITY AND OFFICERS OF THE SOCIETY:**

- a) The officers of the society shall be the Secretary, Joint Secretary, Deputy Secretary, Assistant Secretary and such other functionaries as







may be appointed by the Board. The Secretary shall also be the Ex-Officio Secretary of the Board.

- b) All Officers of the Society, except the Secretary, shall be appointed by the Chairman for such period and on such terms and conditions as the Chairman may think fit and proper. The Secretary shall be appointed by the Chairman with the concurrence of the Government of Telangana.

**13. QUORUM FOR MEETINGS OF THE BOARD:**


Four Members of the Board present in person shall form a quorum at every meeting of the board.

**14. SUITS BY OR AGAINST THE SOCIETY:**

The society may sue or be sued in the name of the Secretary.

**15. FUNDS OF THE SOCIETY:**

- a) The Society shall maintain a fund to which shall be credited all fees and other charges received by the Society and all moneys received by the Secretary by way of grants, gifts, donations, benefactions, requests or otherwise and all other moneys received by the society in any manner or form from any other source.
- b) The said fund shall be applied towards meeting the expenses of the society and the board in the performance of its functions under these rules, bye-laws or regulations, including the allowances payable to the officers and the employees of the society.
- c) The Society shall maintain a fund to which shall be credited
- i. All moneys provided by the Central and State Government
  - ii. All fees and other charges received by the society
  - iii. All moneys received by the society by way of grants, gifts, donations, benefactions, requests or other wise and.
  - iv. All moneys received by the society in any other manner or from any other sources.
  - v. To fix and collect such fees and other charges as may be laid down by the rules, bye-laws or regulations of the society.
  - vi. To deposit all moneys credited into the fund in such banks or to invest in such manner as the society may decide.
  - vii. To borrow or raise moneys with or without securities or on the security of a mortgage, charge, hypothecation or pledge over all or any of the immovable or movable properties belonging to the society or in any other manner.
  - viii. To make or endorse on behalf of the society and to accept or draw in favour of the society any drafts, cheques and notes or other negotiable instruments on the discount charges therefor and for this purpose to execute and sign, such deeds and documents, advance such moneys as may be considered expedient or necessary for the purposes of the society.





**16. CONSTITUTION OF COMMITTEES:**

The Society may constitute such committees, or other bodies as may be deemed fit and to prescribe, by rules of the society, their powers, functions, tenure and other matters.

**17. ACQUISITION & DISPOSAL OF PROPERTIES:**

The Society may acquire, hold and dispose of property in any manner whatsoever for the purposes and in pursuance of the advancement of objects of the society.

**18. ACCOUNTS AND AUDIT:**


- 1) The Society shall maintain proper accounts and other relevant records and prepare an annual statement of accounts showing the income and expenditure of the society for each year.
- 2) The accounts of the society shall be compiled annually by the Chartered Account and submitted to A.G. for audit.
- 3) Each authorized Auditor shall have, in the performance of his duties, at any reasonable time, access to the books, accounts and other documents of the society.
- 4) As soon as may be practicable, at the end of the each year, the audited accounts of the society together with the audit report thereon shall be forwarded to the Government.
- 5) Expenditure incurred in connection with audit shall be payable out of the funds of the society.

**19. ANNUAL REPORT:**

The society shall submit annually, within six months of the closing of the previous year, to the Government of Telangana in the Social (TW) Welfare Department, a report on the working of the Tribal Welfare Residential Schools, Junior Colleges, Degree Colleges and other Institutions managed by it during the year under report, together with an audited statement of accounts showing the income and expenditure for that year.


**20. AMENDMENTS:**

- a) No amendment or alteration shall be made in these Rules and Regulations of the society unless it is voted by two third of members present in a special meeting convened for the purpose and confirmed at a second special meeting.





b) Any such amendment shall come into force on the date immediately following the expiry of three months reckoned from the date of its receipt by the Government in the Social Welfare Department provided that if before the expiry of the said period of three months the Government direct that the amendment shall be modified in any manner or that it shall not be made, the amendment shall have effect only in such modified form or be of no effect, as the case may be.

The Government of India issued Andhra Pradesh Re-organization Act No.6 of 2014 for bifurcation of Andhra Pradesh State as Residuary Andhra Pradesh State and Telangana State.

The Government have communicated the recommendations of Sectoral Sub-Committee on Training institutions and Centers under Schedule 10 of AP Re-organization Act vide Note No. 1379/Planning/plg-XVIII/2014, dt.21.04.2014 of Special Chief Secretary planning principal Secretary, GA (SR), Dept...

The recommendations of the Sectoral Sub-Committee on division of APSWREIS are as follows:-

“Although this is established as a society, in view of the duties performed by the society, it is recommended to divide before AD.

The Standard procedure prescribed for division of Societies in Schedule IX of AP Re-organization Act, 2014 as per the AP Societies Registration Act, 2001.

Section 21(2) of the AP Societies Registration Act, 2001, Amalgamation and division of Societies; Any society may, by a Special Resolution divide itself into two or more societies. Such resolution shall contain proposals for the division of the assets and liabilities of the Society among the new societies into which it is

proposed to divide itself and may specific the area of operation of and the members, who will constitute each of the new societies.


The APTWREI Society was established in 1999 registered under the Andhra Pradesh (Telangana areas) Public Societies Registration Act, 1350 Fasli (Act 1 of 1350 F) and its Registration No.3054 of 1998. Under the above circumstances, the following special resolution may be approved by the Board of Governors.


SPECIAL RESOLUTION :

1. To divide the existing APTWREI Society into 2 Societies i.e., Andhra Pradesh Tribal Welfare Residential Educational institutions Society for Residuary Andhra Pradesh State and Telangana Tribal Welfare Residential Educational Institutions Society for Telangana State.
2. Assets and Liabilities of Society shall be divided among the 2 new Societies as per the area of location and operation of institutions. The area of operation for Residuary Andhra Pradesh State is (13) districts of Seemandhra region and for Telangana State is (10) districts in the existing Telangana Region.
3. The Secretary, APTWREIS is authorized to prepare Bye-laws for both the Societies and to take necessary steps for the division of Society into new Societies (AP residuary State and Telangana State) on the above with the approval of Secretary to Govt., TWD/Vice-Chairman APTWREIS.
