- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) T.T.W.R. Degree College(W)-Devarakonda, the Second Party is engaged in Higher education under state Government of Telangana, affiliated to Mahatma Gandhi University, Nalgonda.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable institution, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds, and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological upgradation, innovation, and competitiveness of an industry. Both parties believe that close cooperation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Consultant support: The first Party will give valuable inputs to the Second Party in attaining NAAC Accreditation, Academic development.
- 2.3 Academic/Skill Development Programs: First party will train the faculty/IQAC members of second Party for developing academic rigour as per Higher education requirement. First party will give valuable inputs to the Second Party for strengthening internal quality of the institution.

Background:

Scope:

Condition:

The MoU is entirely non-commercial and will run with no financial transactions.

Tenure:

This MoU stands valid for three years with provision for modification acceptable to both institutes. This MoU shall become effective upon signature by authorized officials from the MKR Government Degree College Devarakonda and TTWRDCW, Devarakonda, and will remain effective for the aforementioned period until modified or terminated by any one of the partners by mutual consent. In absence of mutual agreement regarding earlier dissolution this MoU shall end on 30-12-2023.
