Purpose:

This MoU outlines the collaboration between Tribal Welfare Degree College for Women, Devarakonda, and Nehru Yuva Kendra for the promotion of youth development and education among tribal students.

Objectives:

The parties agree to work together with the following key objectives:

- Enhancing student engagement and participation in community development activities.
- Promoting educational opportunities for tribal students through collaborative initiatives.

Scope of Collaboration:

Educational Initiatives:

Tribal Welfare Residential Degree College for women, Devarakonda will:

Provide space and support for NYK-led workshops and programs. Collaborate on educational outreach initiatives targeting tribal communities.

Youth Development Activities:

NYK will: Organize skill development workshops, training sessions, and awareness programs for college students. Facilitate youth-led community development projects in collaboration with Tribal Welfare Residential Degree College for women.

Duration of Agreement:

This MoU is effective as of 2-2-2023 and shall remain in force for a period of 5 years, subject to review and renewal by mutual agreement.

Responsibilities and Commitments:

Tribal Welfare Degree College for Women, Devarakonda Responsibilities:

- Provide facilities for NYK-led programs and workshops.
- Collaborate on educational outreach initiatives targeting tribal communities.

Nehru Yuva Kendra (NYK) Responsibilities:

- Organize and conduct youth development workshops and training sessions.
- Facilitate community engagement projects led by college students.

Reporting and Evaluation:

Both parties will collaborate on regular reporting and evaluation of the collaborative initiatives. Schedule periodic review meetings to discuss progress, address challenges, and make any necessary adjustments to the collaboration.

Amendments:

Any amendments to this MOU must be made in writing and agreed upon by both parties.
