- 3. As IQAC cells are established in all institutions and NAAC work is in progress; Research; Innovation and Extension activities to be initiated with precise planning and execution.
- 4. Prepare a list of funding agencies; their time lines and categories in which research proposals can be applied and prepare a flexi to be put up in IQAC

5. Encourage faculty to apply/ complete their Doctoral Degree, since it is an eligibility criterion to apply with most of the funding agencies; would add to their professional CV and also in view of NAAC accreditation process. 6. Fasten the process of acquiring 2(f) status of UGC as it is one of the

- criteria to apply for research funds. 7. Focus of SERB- FIST, for procuring funds to meet laboratory requirements
- and their upgradation as per the syllabus demands. 8. As suggested by Expert Speaker, institutions can plan to devise a MOOCs
- course and upload them in SWAYAM portal or MOOCs websites.

All the above directions have to planned; designed and executed and a 'Plan of Action' of each college should be submitted by 31' August, 2023 without fail. Accordingly, the Higher Education wings of both Societies will monitor and review all proposals.
