Brief information about the activity:

Topic/subject of the activity- Different acts Related to drug abuse

Objectives :

- Prevention: The primary objective is to prevent incidents of ragging and drug abuse from occurring within the institution.

- Enhanced Institutional Reputation: Improved reputation and credibility of the institution as a safe and supportive learning environment, attracting prospective students and fostering positive relationships with alumni and the wider community.
- Long-term Prevention: Sustainable prevention efforts that extend beyond immediate interventions, empowering students to become advocates for a ragging-free and drug-free campus through peer education and positive role modeling.
- Continuous Improvement: Ongoing evaluation and refinement of anti-ragging and anti-drug strategies based on feedback, data analysis, and emerging trends, ensuring adaptability and effectiveness in addressing evolving challenges.
