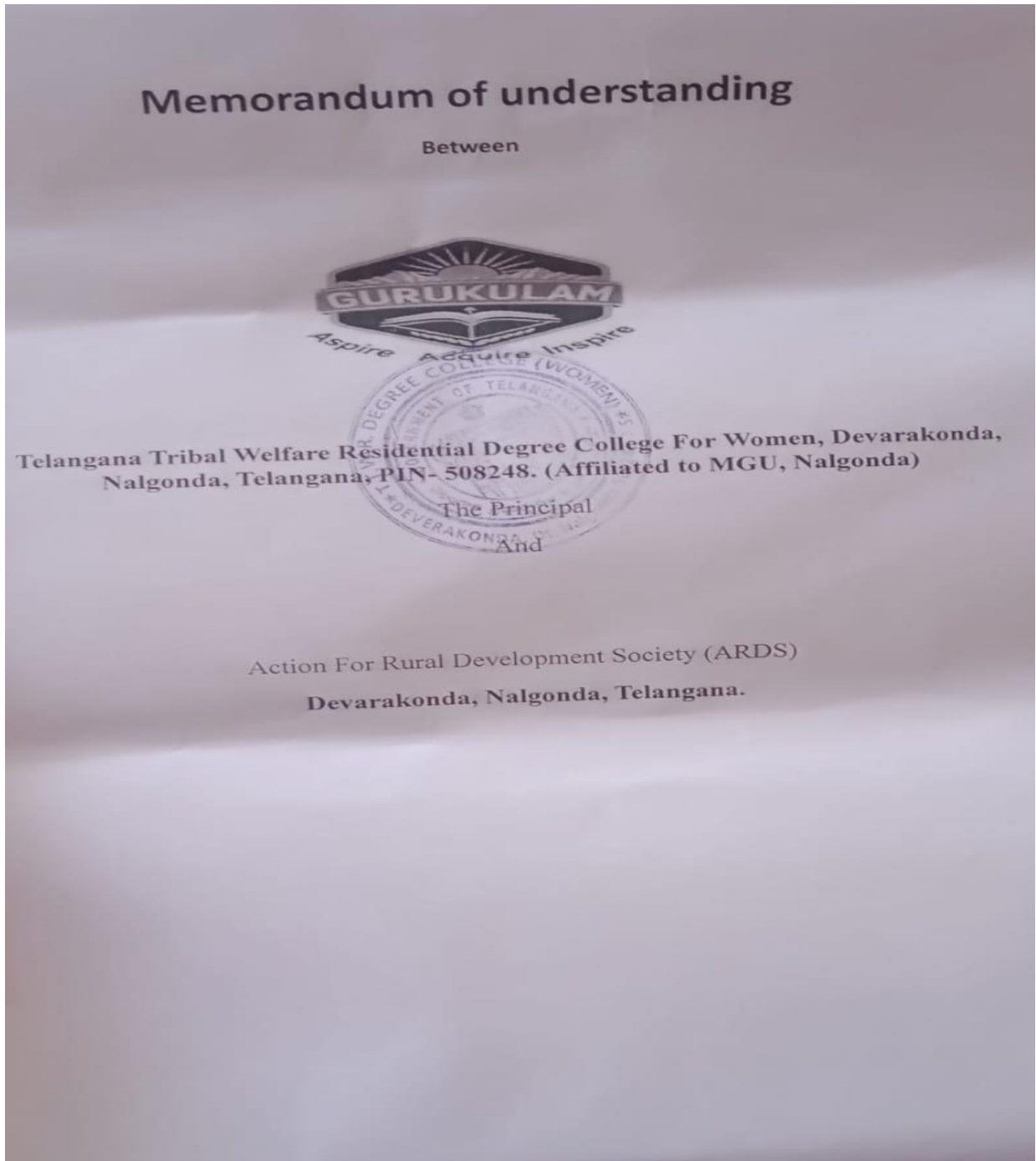

## Memorandum of Understanding (MoU)

Action for Rural Development will conduct workshops, training sessions, and seminars for college students with a focus on entrepreneurship development, imparting practical knowledge and skills.

#### **Incubation Support:**

The Entrepreneurship Development Cell of Telangana Tribal welfare Residential Degree college for women will collaborate with Action for Rural Development to provide incubation support for promising entrepreneurial projects initiated by college students, offering mentorship and resource.

#### **Networking Opportunities:**

Action for Rural Development will facilitate networking opportunities for college students by connecting them with entrepreneurs, industry professionals, and experts to enhance their exposure to the entrepreneurial ecosystem.

**Duration of Agreement:**

This MoU is effective as of 6-11-2022 and shall remain in force for a period of 5 years, subject to review and renewal by mutual agreement.


**Reporting and Evaluation:**




