
**Objectives:**

3. Provision of lab facilities by allowing the Computer Science students of TTWRDC(M) NAGARKARNOOL.
4. Provision of lab facilities by allowing the Computer Science students of TSWRDC(W) Mahabubnagar.

**TERMS OF MOU:**

1. **Duration of MOU:** This MOU shall be effective from the data of signing and shall remain in force for a period of 5 years from the said data.
2. **Termination of MOU:** The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Principal, TSWRDC(W), Mahabubnagar with- a written one month notice to the TTWRDC(M) NAGARKARNOOL in the event of non-compliance.
3. **FINANCE:** TTWRDC(M) NAGARKARNOOL shall not pay any fees associated with the participation of TSWRDC(W), Mahabubnagar staff and in the provision of its academic activities.
4. Both parties assure that this agreement does not go against the rules and regulations of TSWRDC(W), Mahabubnagar. (As it is a Government Entity).

5. If this agreement goes against rules & regulations at a later date and when it comes into light, the agreement will stand nullified automatically or will be cancelled immediately by the principal of TSWRDC(W), Mahabubnagar or TTWRDC(M) NAGARKARNOOL
