ORDER:

As per Para (3) of Guidelines vide reference 1st cited, the Principals of the all the TWRE Institutions were declared as Drawing and Disbursing officers with powers to sanction of expenditure towards contingent charges. They are empowered to sanction the contingent charges expenditure within the ceiling limits communicated by this Office.

In the above said guidelines, item-wise ceilings were fixed in respect of certain heads of expenditure to be incurred at institution level by the Principals of Residential schools and Jr.Colleges. In case of Upgraded Residential Junior Colleges, they will be treated as two units for the sake of expenditure i.e., School portion and Junior College portion. However, as the drawing officer is only one i.e., Principal, only one cash book should be maintained in URJCs.

Based on the enhanced rates of Contingent charges vide reference 3rd cited, the Item-wise, Quarter-wise allocation of contingent charges **Annexure -I** Appended.

Therefore the following amounts are proposed for release of:

- Rs.6,000/- (2000 x 3) towards Honororium of Doctor and Rs.18,000/- (6000 x 3) Honororium of Part-time Plumber & Electrician from Oct to Dec,2023 to each Institution.
- The Contingent charges for the 3rd Quarter of 2023-24 as mentioned below at **Annexure-II appended** of all the TTWRE Institutions.

Therefore, sanction is hereby accorded for an amount of **Rs.1,57,67,400/-** (**Rupees One crore fifty seven lakhs sixty seven thousand and four hundred only**) towards contingent charges for 3rd Quarter of 2023-24 to the above said all TTWRE Institutions from the funds available under Tribal Welfare 310/312 - Other Grants-in-Aid in PD Account No.241 and **Rs.30,00,000/-** (**Rupees Thirty lakhs only**) towards Honororium of Doctor, Part-time Plumber & Electrician 3rd Quarter of 2023-24 to the above said all TTWRE Institutions from the funds available under Gurukulam Academic Activities 300/306- Professionalas Engaged for Specific Activities.

The Principals are authorized to pass the detailed bills at institution level and retain with them for Annual Audit. However, the Principals shall follow the instructions issued in the references $1^{\rm st}$ and $2^{\rm nd}$ cited. They are also requested to submit separate proposals based on actuals for release of Rents, Power Consumption Charges etc.,

Further, they are requested to limit their expenditure for the released amount (eligible) to each sub-detailed head has to be met from the same head of account for which the amount was released and not to divert the amount from one head of account to another head of account. If the actual expenditure is going to exceed the release against each head of account, the same may be sent for approval of the Secretary, Gurukulam and only after such approval, expenditure can be incurred. Any sort of deviation from the above shall not be entertained. If any excess expenditure is incurred more than eligible criteria in any Head of Expenditure shown above, the same will be recovered from the Principals and concerned/in-charges equally besides initiating disciplinary action against them.

All the Principals are directed to enter all the financial transactions with regard to Contingent charges in FAS (before meeting any expenditure or giving

any cheque) strictly duly following the above said item-wise celings which are already fixed in FAS. If any excess amount is incurred over and above the item-wise ceilings, the same will not be accepted in FAS and hence such excess expenditure should personally be met by the Principal concerned.

Vide Circular 2nd cited certain instructions were issued for maintenance of Cash Book and incurring the contingencies expenditure. These instructions should be followed by all the Principals/OSDs of Gurukulam institutions.

The expenditure shall be debited to the following Head of Account.
