## **ORDER:**

As seen from the ref. 4<sup>th</sup> cited the order is from the then Hon'ble MTW, the Procgs issued in 2018 stating that to provide the following Cosmetic/Pocket Money, Dhobi and Barber charges students of TTWRS (B) Ashoknagar, Warangal District into TTWR (Sainik) School:

- Details of diet rates @Rs.50/- per students/per day for providing special diet for students to strengthen them physically.
- Dhobi charges @Rs.10/- with material washing and iron pressing.

Further with the ref. 5<sup>th</sup> cited Barber charges has been finalized for @Rs.28/- per students/per month w.e.f 13.07.2023 for the academic year 2023-

24.

Therefore Sanction is hereby accorded for:

 Cosmetic/Pocket Money, Napkins and Barber charges & Rs.2,17,272/ (Rupees Two lakhs seventeen thousand two hundred and seventy two only) towards Cosmetic/Pocket Money, Dhobi charges and Barber charges for the period from October, November & December, 2023 to TTWRS (B) Ashoknagar, Warangal District Annexure - I appended.

The principals of all the TTWRE Institutions are directed to utilize the Cosmetic/Pocket Money, Barber and Napkin charges for the enrolled students only and to keep the balance amount with them only until further instructions.

The principals are instructed to pass the bills from above said releases at Institution level and retain them at institution level for annual audit.

Further, all the Principals/OSDs are already instructed to incur the expenditure as per actual Strength of the boarders and remit the pending dues to concerned Girijan Co-Operative Societies (GCCs) for the said period so as to release the further stocks as per the indents furnished by the Gurukulam institutions for the next subsequent months and also to furnish the monthly expenditure statements to this office by 10<sup>th</sup> of every succeeding month to Gurukulam Head Office. They may be directed to utilize the funds immediately.
