**MEMORANDUM OF UNDERSTANDING (MOU)**

**Between**  
**TSWRDC(W), MAHABUNNAGAR**  
**And**  
**TTWRDC(M) NAGARKARNOOL**

This Memorandum of Understanding (herein after referred to as "MOU") entered on December 20, 2022, at Mahabunagar by and between: Dept. of Commerce, TSWRDC(W), Mahabunagar, herein after referred as the first party, and TTWRDC(M) NAGARKARNOOL, herein after referred to as the second party

**The First party and the Second Party hereby agree as under:**  
**Provision of Academics Facilities/Activities to the students of both parties.**

**Objectives:**

1. Provision of teaching facilities in needed topics by the Commerce staff of TSWRDC(W), Mahabunagar.
2. Provision of teaching facilities in needed topics by the Commerce staff of TTWRDC(M) NAGARKARNOOL.
3. Provision of lab facilities by allowing the Commerce students of TTWRDC(M) NAGARKARNOOL.
4. Provision of lab facilities by allowing the Commerce students of TSWRDC(W) Mahabunagar.

**TERMS OF MOU:**

1. **Duration of MOU:** This MOU shall be effective from the data of signing and shall remain in force for a period of 5 years from the said data.
2. **Termination of MOU:** The partnership covered by this MOU shall terminate on completion of the stipulated period. The agreement may also be terminated by the Principal, TSWRDC(W), Mahabunagar with- a written one month notice to the TTWRDC(M) NAGARKARNOOL in the event of non-compliance.
3. **FINANCE:** TTWRDC(M) NAGARKARNOOL shall not pay any fees associated with the participation of TSWRDC(W), Mahabunagar staff and in the provision of its academic activities.
4. Both parties assure that this agreement does not go against the rules and regulations of TSWRDC(W), Mahabunagar. (As it is a Government Entity).

5. If this agreement goes against rules & regulations at a later date and when it comes into light, the agreement will stand nullified automatically or will be cancelled immediately by the principal of TSWRDC(W), Mahabubnagar or TTWRDC(M) NAGARKARNOOL
